Representative Experience

- Obtained partial summary judgment in 2021 barring sales representative from recovering gross commissions for more than 180 days under Minnesota's Termination of Sales Representatives Act.
- Obtained \$695,000 settlement for dairy farmer against dairy nutritionist and feed mill in litigation arising out of formulation error (2020-21).
- Served as lead defense counsel in Wisconsin jury trial in 2019; although liability was conceded, plaintiff recovered only 1/4th of alleged losses.

- Tried two cases to jury verdict alleging professional negligence of commercial insurance broker; one resulting in defense verdict and the other in plaintiff recovering less than 25% of its alleged damages.
